





TO WHOM IT MAY CONCERN

This is to certify that registration of land documents is not required in the state of Nagaland with regard to Government land. The normal practice is that the Government issue only land patta to the allottee, be it Government agency or private individuals when the land is allotted by the Government. The land patta is treated as the official or valid document with regard to land. Registration of Land Documents is done only when the land is purchased from private individuals/parties. This is to further certify that the land under the possession of the Nagaland College of Teachers Education, Kohima, is a Government allotted land and therefore registration land documents is not required and the Land Patta issued in favour of the NCTE be treated as official land document.



CHANGE OF LAND USE CERTIFICATE

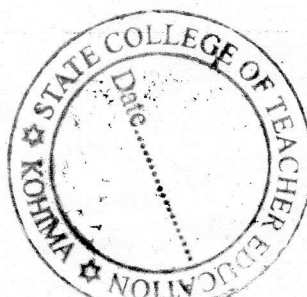


North – Sonuo/4th NAP Camp
